The Management Board of PCF Group S.A. with its registered office in Warsaw (the "**Company**") hereby informs that on 15 December 2020 the Company became aware that the Management Board of the Warsaw Stock Exchange (*Gielda Papierów Wartościowych w Warszawie S.A.*; the "**WSE**") adopted a resolution No. 981/2020 dated 15 December 2020 regarding the admittance of the following securities of the Company to trading on the WSE main market:

- a. 2,062,512 (two million sixty-two thousand five hundred and twelve) series A ordinary bearer shares with a nominal value of PLN 0.02 each;
- b. 25,437,488 (twenty-five million four hundred and thirty-seven thousand four hundred and eighty-eight) series A shares with a nominal value of PLN 0.02 each provided that they are conversed into ordinary bearer shares;
- c. 2,062,512 (two million sixty-two thousand five hundred and twelve) series B ordinary bearer shares with a nominal value of PLN 0.02 each provided that the increase of the share capital of the Company through their issuance is registered; and
- d. 2,062,512 (two million sixty-two thousand five hundred and twelve) rights to series B ordinary bearer shares with a nominal value of PLN 0.02 each.
